HIGH ROCK TREKKERS 4 WHEEL DRIVE CLUB  
RELEASE & INDEMNITY AGREEMENT

This agreement is between the undersigned, \_\_\_\_\_, hereinafter referred to as the "PARTICIPANT", and THE HIGH ROCK TREKKERS, its directors, members, representatives, agents and assigns, hereinafter referred to as "SPONSOR(S)" and/or "TREKKERS". The agreement is entered into between the parties relative to an event sponsored by the TREKKERS and commonly referred to as the LASSEN APPEGATE EMIGRANT TRAIL RIDE scheduled to commence on or about \_\_\_\_\_, at or near \_\_\_\_\_. Nevada, and ending at or near Cedarville, California on or about \_\_\_\_\_. For and in consideration of being permitted to participate in the subject event, PARTICIPANT agrees to all of the terms and conditions set forth herein.

**ASSUMPTION OF RISKS**

PARTICIPANT acknowledges that s/he is aware that the sport of "four wheeling" and "off highway" sports has inherent risks associated with the activities. Some of the risks include, but are not limited to, collisions, rollovers, ejection from vehicle, injury, death and damage to the vehicles. When such activities occur in remote areas, such as the LASSEN APPEGATE TRAIL, it can be difficult or impossible to summon and obtain necessary emergency medical treatment and that any delay may result in further injury or death. PARTICIPANT acknowledges that s/he, and their passengers, know of such risks and assume personal responsibility for these inherent risks, as well as any and all risks whether foreseen or unforeseen.

**PARTICIPANT'S VEHICLE/SEATBELT USE**

PARTICIPANT represents that his/her vehicle has been inspected and is in good mechanical condition and equipped with properly functioning safety equipment, such as seatbelts. PARTICIPANT represents that s/he will use her/his seatbelt at all times while operating the vehicle, whether off-road or on-road, and will personally ensure that all passengers in the vehicle wear seatbelts at all times as well. Furthermore, PARTICIPANT acknowledges that the risk of injury is much greater and injuries can be worse when seatbelts are not in use. PARTICIPANT further represents that his/her vehicle is in compliance of all laws, federal and state (including Nevada and California), relating to off highway vehicle use.

**INSURANCE**

PARTICIPANT represents that her/his vehicle is insured for liability and that their policy is in compliance with all laws of the State of Nevada and State of California. SPONSOR suggests that all vehicles carry liability limits greater than the "minimum" limits required by law. PARTICIPANT also represents that s/he will provide evidence of an active liability insurance policy, naming the vehicle used in the event, if requested.

**MINORS**

Should PARTICIPANT have any minor children as a passenger, s/he represents that s/he is a parent of the child with full authority to obtain any and all medical treatment or is a legal

guardian with proper written authorization to obtain any and all medical treatment the minor may require in connection with their participation in the subject event.

**INDEMNITY AGREEMENT**

In further consideration for allowing PARTICIPANT to participate in this event, PARTICIPANT releases the HIGH ROCK TREKKERS, its directors, members, representatives, agents and assigns from responsibility and/or legal liability for any claims, lawsuits, injuries or damages and rights that PARTICIPANT may have or later obtain as a result of participating in the subject event including those of which PARTICIPANT is currently unaware.

PARTICIPANT agrees to pay all costs and attorney fees, incurred by any of the SPONSORS in defending and investigating any claim or lawsuit brought by or on PARTICIPANT’S behalf, on behalf of PARTICIPANT’S passengers, or on behalf of others whether arising in whole or in part from participation in the subject event.

PARTICIPANT agrees to hold harmless, defend and indemnify SPONSORS and its directors, members, representatives, agents and assigns from any loss, liability, damage or cost that may be incurred due to PARTICIPANT’S participation in the subject event including injury or damage to myself, my passengers, and other persons or property whether caused by SPONSOR’S negligence or otherwise.

**ENFORCEMENT OF AGREEMENT & SEVERABILITY**

PARTICIPANT understands and agrees that if any particular provision or portion of this agreement is found to be invalid or unenforceable for any reason, the remainder of the agreement remains enforceable.

**ENTIRETY OF AGREEMENT**

The parties agree and hereby stipulate that this Agreement and the attachments (Sign-Up sheet) contain the entire agreement of the parties with respect to the subject matter of the agreement and supersedes any prior or subsequent negotiations, representations, or agreements and understandings with respect thereto. This agreement may only be amended by a written document duly executed by both parties.
